Maifest is sponsored by the Jacksonport Advancement Corporation. It includes well-advertised activities: parade Saturday morning, Children's activities, live music all day both days, horsepull, 10K run, softball tournament, a variety of food and beverages, and, of course the Art Fair.

POLICIES:

1. All work that is displayed for sale **MUST** be made by the exhibitor. **NO BUY/SELL**
2. No work made with the use of commercial kits, molds or patterns.
3. Booth space is 12 x 12. Each artist must have his/her own space, and if needed, may rent two spaces. Booths will be pre-assigned and posted.
4. There is no electrical service in the park.
5. There is no parking in, or adjacent to either display area. All exhibitors must park behind the baseball field or across from the baseball field (the baseball field is located on Co V about ½ blocks W of Hwy 57).
6. No refunds in case of inclement weather.
7. Please use the **Large Dumpster** for boxes, packing material, etc located at the Northeast corner of Lakeside Park on Lake Park Drive. Trash barrels are for park and food trash.
8. Registration deadline is March 31, 2012.

REGISTRATION:

Please mail a check for \$90 for each space requested (NON-REFUNDABLE, IF VENDOR IS ACCEPTED) with your application form and the Wisconsin State Vendors form. Make check payable to **JACKSONPORT ADVANCEMENT CORPORATION**. **Please include a large self-addressed, stamped envelope. Notification will be prior to April 25, 2012.** Artists and craftsmen must submit TWO slides representing their work. If accepted these photos will be returned at showtime. If not accepted, they will also be returned. If you exhibited at Maifest last year and your work is the same, you need not submit photos/slides. Directors of Maifest reserve the right to have removed, at showtime, any work they feel is distasteful or not representative of the quality of work described on the application and photos/slide process or any **BUY/SELL items**.
