**Date:** Memorial Day Weekend, Saturday & Sunday, May 27-28, 2017

**Time:** 9:00 AM – 4:00 PM Saturday, 9:00 AM – 3 PM Sunday

**Set-up Time:** Saturday 7:00 AM to 9:00 AM

**Place:** Lakeside Park & Erskine Rest Area, Jacksonport, WI at the intersection of HWY 57 & County V

Maifest is sponsored by the Jacksonport Advancement Corporation. It includes well-advertised activities: parade Saturday morning, children's activities, live music both days, horse pull, 10K run, a variety of food and beverages, and, of course the Art Fair.

**Maifest Policies:**

1. All work that is displayed for **sale MUST be made by the exhibitor. NO BUY/SELL/wholesale/distributor.**
2. No work made with the use of commercial kits, molds or patterns.
3. Booth space is 12 x 12. Each artist must have his/her own space, and if needed, may rent two spaces. Booth assignments will be posted on picnic tables on each side of Hwy 57 on Friday, May 26 by noon, and you will be giving your booth number by email prior to that weekend.
4. There is no electrical service in the park.
5. There is no parking in, or adjacent to either display area. All exhibitors must park behind the baseball field or across from the baseball field (the baseball field is located on Co V about ½ blocks W of Hwy 57). The layout of both parks makes loading and unloading very congested.
6. No refunds in case of inclement weather.
7. Please use the large dumpster for boxes, packing material, etc. located at the northeast corner of Lakeside Park on Lake Park Drive. Trash barrels are for park and food trash.
8. Application deadline is April 1, 2017.
9. Notification will be by April 17, 2017. **After notification the application fee is non-refundable to accepted vendors. Space permitting, applications received after April 17, will pay \$105.**
10. Directors of Maifest reserve the right to have removed, at showtime, any work they feel is distasteful, not representative of the quality of work described/photographed in the application plus any BUY/SELL items.
11. Official setup is from 7 – 9 a.m. Saturday a.m. Vendors may set up on Friday afternoon; however there is NO SECURITY on Friday overnight.
12. Security is provided Saturday overnight.

**Every application must include all items below:**

- Completed application form, below.
- \$95 check payable to Jacksonport Advancement Corporation for each space requested.
- Completed "Wisconsin Temporary Event Operator and Seller Information" form.
- TWO photos of your work AND a THIRD PHOTO of your booth as it appears when set up.
- a self-addressed, stamped envelope for acceptance/rejection notification unless you select email notification on your application.
